**BILLING:** If this agreement is signed by the Principal of your school an invoice will be mailed no more than 15 days after your event. Credits for returns received after 10 business days of the date your sale ends may not be on your final invoice. We also accept all major credit cards.

**PAYMENT** is due within 7 days of receipt of invoices.

**TAX EXEMPTION:** To be exempt from paying taxes Missouri law requires we have a copy of your organizations tax exemption letter on file. You may fax those with your order or send them with your final payment.
